ANNUAL TITLE I PARENT MEETING

TITLE I, PART A PROGRAM

REQUIREMENTS OF THE TITLE I, PART A PROGRAM:

EACH SCHOOL RECEIVING TITLE I, PART A FUNDS SHALL CONVENE AN ANNUAL MEETING, AT A CONVENIENT TIME, TO WHICH ALL PARENTS OF PARTICIPATING CHILDREN SHALL BE INVITED AND ENCOURAGED TO ATTEND, TO INFORM PARENTS OF THEIR SCHOOL'S PARTICIPATION UNDER THIS PART AND TO EXPLAIN THE REQUIREMENTS OF THIS PART, AND THE RIGHT OF THE PARENTS TO BE INVOLVED. ESSA SECTION 1116 (C)(1)

PARENTS HAVE THE RIGHT TO BE INVOLVED IN THE SCHOOL'S PROGRAMS AND WITH SPECIFIC OPPORTUNITIES FOR PARTICIPATION: VOLUNTEER IN CHILD'S CLASSROOM, OBSERVE CLASSROOM ACTIVITIES, PARTICIPATE IN DECISIONS RELATING TO THE EDUCATION OF THEIR CHILDREN, ASSIST IN THE REVIEW AND REVISION OF POLICY, COMPACT, AND TITLE I PLAN, SERVE ON PARENT ADVISORY BOARD, ETC.

TITLE 1 PLAN

THE CAMPUS TITLE I PLAN (CIP) ADDRESSES HOW THE CAMPUS WILL USE TITLE I, PART A FUNDS WITHIN THE SCHOOL DISTRICT. IN TEXAS, REQUIREMENTS OF THE TITLE I PLAN ARE INCORPORATED INTO THE DISTRICT IMPROVEMENT PLAN (DIP) AND THE CAMPUS IMPROVEMENT PLAN (CIP).

- TITLE I, PART A PARENTS HAVE THE RIGHT TO BE INVOLVED IN THE DEVELOPMENT OF THIS PLAN

TITLE 1 PLAN

OUR TITLE I FUNDS HAVE BEEN PRIORITIZED TO SUPPORT STUDENT ACHIEVEMENT IN THE FOLLOWING WAYS:

- **STAFF** – TITLE MANAGER, ACADEMIC ADMINISTRATOR OF BEHAVIOR & INSTRUCTION,, 504 & SPED COMPLIANCE, ALTERNATIVE BEHAVIOR PROGRAM STAFF (4), PARENT ENGAGEMENT TEAM (8), LICENSED PROFESSIONAL COUNSELOR, SOCIAL WORKER, CURRICULUM COORDINATOR, MATH SPECIALIST, READING SPECIALIST/LIBRARIAN, ENTRY-LEVEL MARKETING
- **PROGRAMS** – TUTORING SERVICES, LEADER IN ME, COLLEGE BRIDGE, TRANSLATION SERVICES, NEARPOD, SC
- **PROFESSIONAL DEVELOPMENT** – LEADERSHIP, PARENT & FAMILY ENGAGEMENT, IN-PERSON STAFF MEETINGS
- **MATERIALS/SUPPLIES** – HOTSPOTS (MKV, HOMELESS, FOSTER), GRADUATION CAP & GOWNS, PROM, 2 FAMILY OUTINGS, AND EOY CELEBRATION
- **PARENT/FAMILY ENGAGEMENT** – PARENT OUTINGS, PARENT FOCUSED TRAINING AND SUPPORT,

DISTRICTS THAT RECEIVE MORE THAN \$500,000 IN TITLE I FUNDS ARE REQUIRED TO SET-ASIDE A MINIMUM OF 1% OF THE TITLE I, PART A ALLOCATION FOR PARENT AND FAMILY ENGAGEMENT.

- §OF THE 1%, 90% MUST BE ALLOCATED TO THE TITLE I SCHOOLS IN THE DISTRICT TO IMPLEMENT SCHOOL-LEVEL PARENT AND FAMILY ENGAGEMENT OPPORTUNITIES
- §OUR CAMPUS RECEIVES TITLE I PARENTING FUNDS
- §TITLE I PARENTS HAVE THE RIGHT TO BE INVOLVED IN THE DECISIONS REGARDING HOW THESE FUNDS WILL BE USED FOR PARENT AND FAMILY ENGAGEMENT ACTIVITIES.

Report findings to parents and families and use those results to revise the parental involvement policy and school-parent compact


